WHAT IS THIS PRODUCT ?

Type

This Product (or the "Fund") is a sub-fund of Aequitas, an open-ended umbrella fund, organized as a Luxembourg investment company with limited liability and with variable capital (a "SICAV"), a UCITS investment fund.

Term

The lifespan of this Product is not limited.

Objectives

Aequitas Exclusive Fund is a "fund of funds" that invests in UCITS-funds and ETF's (Exchange Traded Funds) with an excellent track-record combining long-term growth and acceptable volatility. Aequitas Exclusive Fund can invest up to 100 % in UCITS-funds and ETF's that offer Equity and Bond exposure. However in exceptional periods of high uncertainty and stress the fund may also invest up to 100 % in Money Market UCITS-funds. The reference currency of the Product is EUR.

This share class is an accumulating share class. Income received by the Product will automatically be reinvested and the value reflected in the price of the share class.

The summary risk indicator assumes you keep the Product until maturity end of the recommended holding period (5 years).

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

In addition, you will be exposed to the following risks (not captured in the synthetic risk indicator), namely :

Concentration risk: To the extent that the Product investments are concentrated in a particular country, market, industry or asset class, the Product may be susceptible to loss due to adverse occurrences affecting that country, market, industry or asset class.

Interest Rate Risk: By definition, interest rate risk corresponds to the possibility for an investment fund to be negatively impacted by a change in interest rates. The interest rate risk can thus manifest itself through a reduction in financial income in the event of a fall in interest rates and/or an increase in financial expenses in the event of a rise in interest rates. An increase in interest rates may cause the value of fixed-income securities held by the Product to decline.

Small capitalisation: The Product invests significantly in smaller companies which can carry a higher risk because their prices may be subject to higher market fluctuations than those of larger companies.

Investments into other UC/UCITS: A Product which invests in other collective investment schemes will not have an active role in the day-to-day management of the collective investment schemes in which it invests. Moreover, a Product will generally not have the opportunity to evaluate the specific investments made by any underlying collective investment schemes before they are made. Accordingly, the returns of a Product will primarily depend on the performance of these unrelated underlying fund managers and could be substantially adversely affected by the unfavourable performance.

Currency risk: The Product invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

Performance Scenarios

What happens if Funds Avenue S.A. is unable to pay out ?

The assets of the Fund are held by its depositary CACEIS BANK, Luxembourg Branch (the 'Depositary'). In the event of insolvency of the PRIIP manufacturer, the assets of the Fund would not be affected. The Depositary is legally required to segregate its own assets from those of the Fund. However, there is no compensation or guarantee mechanism that could cover potential losses. This Product does not provide any protection against future market developments and you could lose all or part of the amount invested.

Costs over time

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the Product performs as shown in the moderate scenario ;
